Dear Attorney General,

The purpose of this correspondence is to request a formal and open federal investigation into the abomination of human trafficking, drug trafficking and the child sex slavery industry in Indiana. I believe the focus of this investigation should be on the primary criminals that allow, coordinate, assist and protect those that handle the day to day operations of these felonious activities. Specifically, former Indiana Governor and now Vice President Mike Pence, Indianapolis FBI division leader Robert Jones and former U.S. Attorney, now Indianapolis Mayor, Joe Hogsett.

I respectfully request you do a thorough review of my video on human trafficking at [www.piperforsenate.com](http://www.piperforsenate.com). It will provide and explain in detail evidence that crimes were committed and investigation is warranted. Based on the overwhelming public evidence of FBI criminal behavior over the past several years, I am confident you will find all that is required to initiate this investigation.

Since 2005, I have been engaged in the pursuit of justice regarding these illegal activities in Indiana and have been dismissed by all elected state and federal officials. Now things have changed. The following elected officials and public figures are joining the fight; President of the United States Donald J. Trump in his speech on June 19, 2018, Arkansas Senator Tom Cotton, Ohio Senator Robert Portman, Attorney General of Florida Pam Bondi, and radio personalities Rush Limbaugh, Laura Ingraham and Vice President Mike Pence's best friend Greg Garrison.

All these highly respected people agree that these *inhumane crimes against children are real* and are growing out of control. Everyone knows that this can only exist if the highest levels of state and federal government allow it. Since 2009, I have met three times with Mike Pence and twice with the FBI to discuss and seek an end to these horrible crimes. Both have refused to assist in any way.

Why?

I believe it is because they are directly involved.

The nation is now rightfully focused on the crisis at the southern border but it would be intellectually dishonest not to allow all Americans to have a full understanding of how and why it got to this point. Without hesitation I believe the genesis is personal political advancement and greed. It is also essential

that this investigation begin immediately so as to be front and center for the voters in the 2018 midterm elections.

The sole purpose of my U.S. Senate campaign has been to raise national awareness of how horrific the crisis is in Indiana and the entire United States. Even radio talk show host Laura Ingraham agreed and stated on her April 25, 2018 program ***"Human trafficking is a national emergency. As a country we are aiding and abetting drug cartels and human traffickers"***. She could not be more correct. That is why I have traveled to Washington D.C. three times in the last year in hopes of speaking with anyone at the White House or any of Indiana's elected officials. All have refused!

Why?

Everyone is protecting Vice President Mike Pence and the FBI....No matter how many children are trafficked, raped and killed....No matter how many thousands of pounds of drugs are smuggled into Indiana.... No matter how many children overdose on those drugs and die.... No matter how many children commit suicide on those drugs.... No matter how many children are killed in the streets by drug gangs. *All that matters is that Vice President Mike Pence and the FBI remain protected.*

Now that the whole country is becoming aware of this modern-day slavery here in Indiana, any attempt to delay an investigation could and should be perceived as a crime against humanity.

It is my belief that the media's silence on this issue over the years and the media's covering up for Vice President Mike Pence has grotesque similarity to the media's protection given to former President Bill Clinton over his sexual assaults and molestations.

To be fully transparent, I intend to distribute this request to all major media outlets and place it on social media. Even though I have been banned from Facebook for the same reason that Diamond and Silk have been banned, I intend to have others post it for me. Also, every TV news show and radio program in Indiana, including Comcast media, has refused to air any of my content. Therefore, I will be sending this to all national TV news programs and newspapers. It will also be emailed to all 15,000 clients at my hospital, including current and former local and federal law enforcement officials and elected officials. This will ensure public knowledge of this request, ability to read the letter for themselves, and realization that you have the information and obligation to pursue the investigation.

Given the severity of the criminality that I have personally witnessed involving Vice President Mike Pence and the FBI, I respectfully request an immediate investigation. As a patriot, it is my obligation to do all I can to bring this issue to your attention and to the nation's.
