ABOUT THE DISTRICT

The United States Attorney for the Southern District of Indiana is the Chief Federal Law Enforcement Officer for the District. The United States Attorney enforces the federal criminal laws in the Southern District of Indiana in the United States Courts, represents agencies of the United States in civil cases, and argues on behalf of the United States to the United States Court of Appeals for the Seventh Circuit.

The Southern District of Indiana consists of the southern sixty (60) counties of the state. The District is divided into four (4) divisions: Indianapolis, Terre Haute, Evansville, and New Albany.

Cases are filed in the Division having venue of the action, with certain exceptions (e.g. cases which normally would fall into different divisions but which are related to one another by defendant and/or subject matter will often be accepted for filing in a single Division).

The United States Attorney's Office is based in Indianapolis, with a staffed office in Evansville, and unstaffed offices in New Albany and Terre Haute.

The Mission of the United States Attorney's Office is to:

- Fairly and justly prosecute violations of federal criminal law and to represent the United States and its agencies in civil litigation;

Dear Mr. Piper:

Chief Justice Rush asked me to respond on her behalf to your letter of September 25, 2018, requesting an investigation of an attack against you. Thank you for expressing your concerns.

Please understand, though, that the Indiana Supreme Court's jurisdiction is limited to the consideration of cases and controversies properly brought before it from lower courts in accordance with state law and the Indiana Rules of Court. The materials you have sent do not come within any laws or rules of court that define the Supreme Court's jurisdiction.

Particularly, the Court has neither the power nor the ability to carry out an investigation as you request. Courts and judges must remain neutral to *decide* cases. *Investigating* a case would tend to place the Court in the role of a partisan advocate, instead of the impartial arbiter that Due Process requires. So I'm glad to see that you've also sent your letter to attorneys general, a prosecutor, and the State Police—all of whom, unlike the Court, do have investigatory authority.

I regret we cannot be of assistance.

I am a Federal Whistleblower, and you damn well know it.

It's been one year and six months since the attempt on my life by Charles Stuart. This attack took place on July 25th 2018 while I was the Independent candidate for the United States Senate seat held by Joe Donnelly. Stuart committed a major felony in an attempt to Protect V.P. Giffords and the murder of Federal Judge John Roll standing nearby. We all remember the attempted murders of Senator Rand Paul and Congressman Steve Scalise.

As you can see, from the information provided, I took the liberty of going to the U.S. Attorney's website and verifying your position and responsibilities. These include enforcing Federal crimes and fairly and justly prosecuting violations of criminal Federal Law in the Southern District of Indiana.

Therefore, you are well aware that the list below are Federal Crimes and all were committed against me.

- It is a Federal crime to try to kill a candidate running for the United State Senate, a Federal office.
- It is a Federal crime for Governor Holcomb to order the FBI not to investigate this attack.
- It is a Federal crime for the FBI to violate its sworn duty and not investigate this attack.
- It is a Federal crime for Governor Holcomb to order the State Police not to investigate this attack.
- It is a Federal crime for Governor Holcomb to order the Indiana Attorney General not to investigate this attack.
- It is a Federal crime for YOU not to have your subordinates investigate this attack.
- It is a Federal crime for Governor Holcomb to order no police report or investigation from the local sheriff's department.

It is your job to prosecute all these people and let the public know that you are doing so. You must be completely transparent.

Governor Holcomb's actions were to protect V.P. Pence and the FBI. He is furious that I am a Federal Whistleblower and am telling the truth about sex trafficking, drug trafficking, government payoffs and bribes on I-69/NAFTA HIGHWAY and the selling of half of all the medical seats at Purdue's Vet School.

It is my belief that when President Trump finds out, and he absolutely will, with the help of the national media, that you knew about all this and refused to do your duty so as to protect V.P. Pence and the FBI. President Trump WILL CONSIDER YOU PART OF THE DEEP STATE and a co-conspirator.
