I am a Federal Whistleblower, and you damn well know it.

It has been over two years since the attempt on my life by Charles Stuart. This attack took place on July 25<sup>th</sup> 2018 while I was the Independent candidate for the United States Senate seat held by Joe Donnelly. They will know if you withhold anything or alter any evidence.

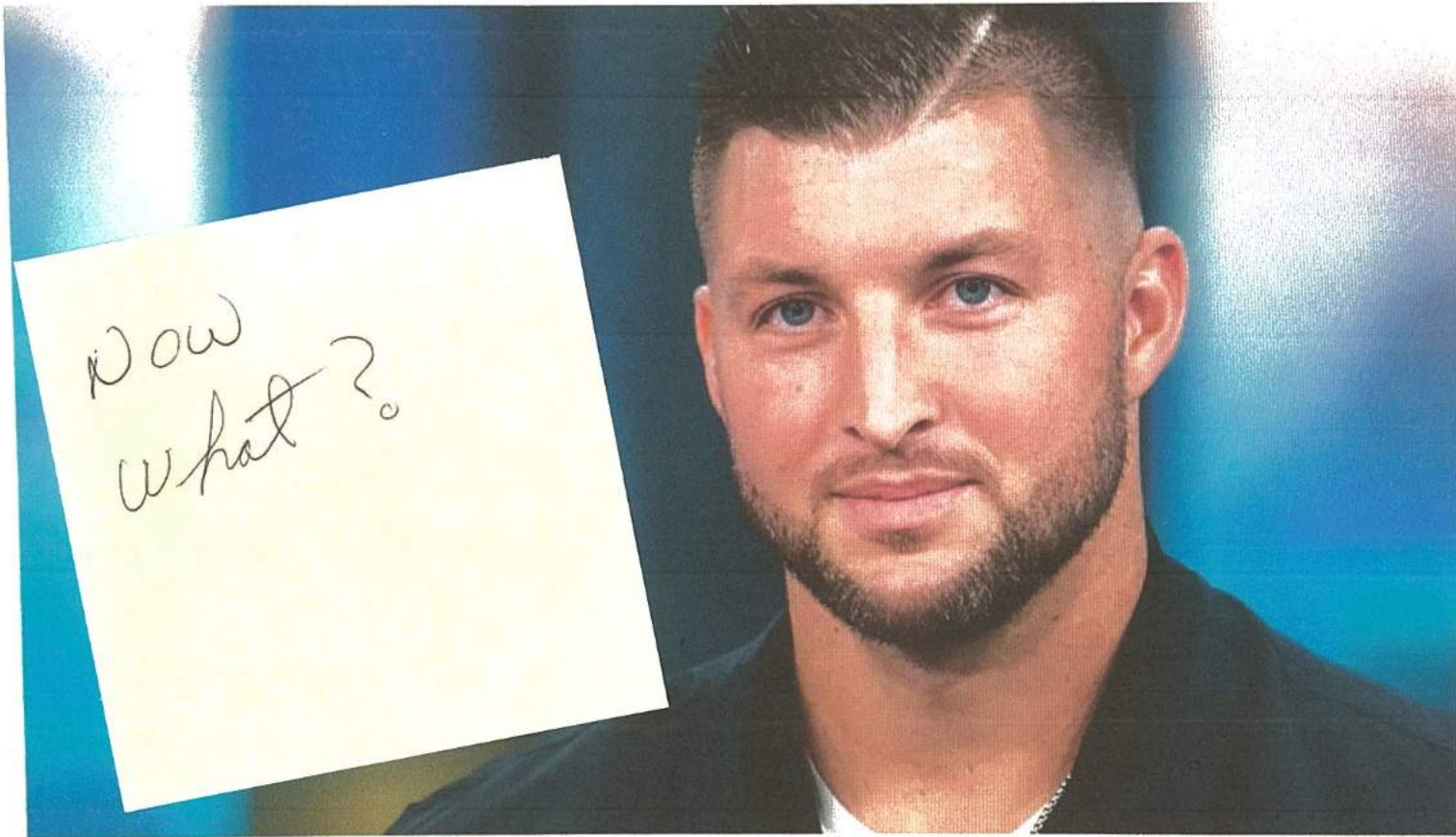
