Dear John Piper,

On or about October 10, 2025, a representative of the Department of Natural Resources (DNR) observed the following:
Tree clearing and fill in the floodway of Crooked Creek.

According to local property ownership records, you are the property owner. If you did not personally do the work in question, please provide the name and contact information for the person or business who did the work.

The Flood Control Act (Indiana Code 14-28-1) requires prior approval from the Department of Natural Resources (DNR) to make, use, or maintain a structure, an obstruction, a deposit, or an excavation in or on a floodway. A search of our files indicates that a DNR permit has not been granted for this project.

The floodway is defined as 1) the channel of a river or stream, and 2) areas of the floodplain adjoining the channel that are required to efficiently carry and discharge the flood flow of a river or stream. Recent historic floods have threatened the lives of Indiana residents and caused substantial damage to property at numerous locations within the state. Regulation of construction activities located in floodways is a matter of extreme importance. Floodway construction projects must be designed according to sound engineering practices and applicable floodway regulations. The Flood Control Act (IC 14-28-1) requires a permit for most construction activities located in or on a floodway. A map showing the floodway limits on your property is attached.

Contact the DNR in writing via email to jwalling@dnr.in.gov or at the address above within 14 days and provide a timeline for timely restoration (within 60 days). A restoration plan including a completion schedule must be coordinated with and accepted by the DNR Division of Water.

Failure to restore the project site may result in a Notice of Violation. DNR is offering an opportunity to correct this violation under IC 4-21.5-2.5-7 by restoring the site. Once a restoration plan has been agreed upon and implemented please provide notice with photos to our office within 30 days of completion. Compliance with this letter is not an admission that a violation occurred as stated in IC 4-21.5-2.5-8(a)(3).

We would prefer to resolve this issue without the need for a formal Notice of Violation. Please contact me with any questions at 317-391-7752, or via email at jwalling@dnr.in.gov.

Dear Mr. Piper:

Chief Justice Rush asked me to respond on her behalf to your letter of September 25, 2018, requesting an investigation of an attack against you. Thank you for expressing your concerns.

Please understand, though, that the Indiana Supreme Court's jurisdiction is limited to the consideration of cases and controversies properly brought before it from lower courts in accordance with state law and the Indiana Rules of Court. The materials you have sent do not come within any laws or rules of court that define the Supreme Court's jurisdiction.

Particularly, the Court has neither the power nor the ability to carry out an investigation as you request. Courts and judges must remain neutral to *decide* cases. *Investigating* a case would tend to place the Court in the role of a partisan advocate, instead of the impartial arbiter that Due Process requires. So I'm glad to see that you've also sent your letter to attorneys general, a prosecutor, and the State Police—all of whom, unlike the Court, do have investigatory authority.

I regret we cannot be of assistance.

The Environmental Protection Agency violated federal law by fining a Wyoming farmer \$37,500 a day for building a stock pond on his own property, a new lawsuit alleges.

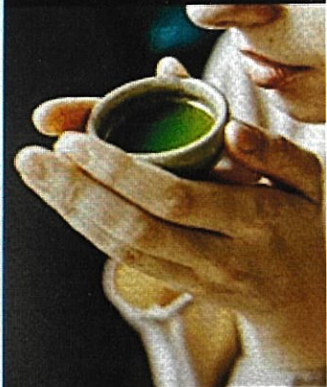
Andy Johnson now faces more than \$16 million in fines even though he may have never violated the Clean Water Act as the EPA contends.

"The EPA is clearly acting beyond its authority, because the Clean Water Act exempts stock ponds from any requirement for a federal permit," Jonathan Wood, a staff attorney for the Pacific Legal Foundation, which is representing Johnson, charged.
